## AB 2356 Repo Bill

Credit card language, T-ROC worked on improving language to limit a towers time when credit cards from Repo Agents are not approved.

**CHP Regulatory Matters:** ELD as early as 2019, working to get Federal standard adopted and increasing to 150 air miles.

Hours of service regulations to accommodate relief for tow truck drivers, which were negated by TROC.

**Key court decisions:** surcharges are legal. Check your contracts to see if there are surcharge prohibitions.

California Supreme Court decided by Dynamex case in April 2018, landmark decision making it much more difficult AB 2392 (Santiago)-Insurance bill
